





NSRLP Mandates



COLLABORATION & OUTREACH

January - March 2017

The NSRLP's Blog wins a second Clawbie Award! First place in the new "Change and Advocacy" Category.

"Our new award category seeks to recognize blogs that drive positive change in the legal system. ... Prof. Julie Macfarlane's essential blog [tracks] progress in the fight to improve access to justice".

Nikki Gershbain begins her work to encourage the integration of coaching services into the practice of family law in Ontario, commencing with stakeholder consultations with lawyers and SRLs. Publication of our latest <u>SRL Intake Report</u>, collating and analyzing the information received from 73 SRLs who completed the <u>Intake</u> <u>Form</u> between April 2015 and December 2013.

➢NSRLP provides a summary of the Bonkalo recommendations on family legal services on the website, and encourages SRLs to submit feedback to the Review.

➤The NSRLP is awarded intervenor status in the forthcoming SCC case of <u>Pintea v Johns</u> (pro bono counsel Ranjan Agarwal, Bennett Jones).

The first prototypes for the SRL Case Law Database are developed by Lead RA Lidia Imbrogno, tested and refined

April - June, 2017

April 18th, the NSRLP heads to the Supreme Court of Canada to watch the presentation of arguments – and judgment from the Bench - in *Pintea v Johns*. The SCC endorsed the *Canadian Judicial Council's Statement of Principles on Self-Represented Litigants and Accused Persons*.

➢ For the first time, National A2J Action Committee members meeting in Vancouver work directly with SRLs. 10 local SRLs participate as guests of the NAC, and discuss an SRL case study (Judy Gayton, who Skyped in).

Julie presents the Green College Public Lecture on "Public Engagement & Political Discourse Over Access to Justice" The Ontario Court of Appeal applies Pintea v Johns for the first time in Moore v Apollo Health & Beauty Care. Justice Brown's judgment discusses the challenges faced by SRLs navigating court systems, and the responsibility of judges to "meet the need for simplicity" for SRLs by providing a non-prejudicial and engaged courtroom.

➢ NSRLP writes two submissions in response to Ontario's Bonkalo Review – one on the licensing of paralegals to work on some family matters, and a second (by Nikki) on the use of limited scope retainers and legal coaching.

➢NSRLP establishes an online petition to try to include more public voices in the debate over the expansion of paralegal practice in Ontario.

July - September, 2017

The NSRLP releases Version 5 of the Access to Justice Annotated Bibliography, including over 100 summaries on access-to-justice material in the Canadian, American, and International context, as well as a new section dedicated to unbundling and legal coaching.

- NSRLP announces SRL Awareness Day 2017. Four Ontario law schools commit to participating (Windsor, Ottawa, Osgoode, and Queens).
- The 2d of Julie's The New Lawyer integrating new SRL data and challenges for counsel – is published on August 1

Following a grant from the Foundation for Legal Research, NSRLP hires three new case readers for the SRL Case Law Database.

- Julie is voted one of Canada's 25 Most Influential Lawyers by Canadian Lawyer magazine in the Human Rights and Advocacy category.
- Windsor Law offers a for-credit SRL Conflict Coaching Class. This is the second time this has been offered at Windsor and to date is the only SRL coaching class in an North American law school. Windsor law students are paired with SRLs and provide their SRL "clients" with procedural information and guidance, help with form completion, preparation for events such as case conferences, case management hearings, and mediation. The course instructor is Windsor family lawyer Georgette Makhoul, of Hogarth, Hermiston & Severs LLP.

- The NSRLP launches a podcast Jumping Off the Ivory Tower with Prof Julie Mac, hosted by Julie and Dayna. The podcast tackles topics from across the social justice universe, often focusing on A2J and SRLs. Each podcast features a special guest.
- NSRLP publishes a new SRL Primer, "<u>Reading and Understanding Case</u> <u>Reports: A Guide for Self-Represented Litigants</u>"
- SRL Awareness Day takes place in Windsor Law, Queens and Osgoode on October 4th, with an event planned for Ottawa later in the Fall.
- ➢ The Access to Justice and SRLs Certificate Workshop is held at Windsor Law for the second time. A French language version is planned for Ottawa U. this fall.

- ➢ John and Becky present at the U of Ottawa's A2J conference
- Dayna presents at the American Bar Association's first conference on Unbundling in Denver
- NSRLP releases a new SRL Primer "Navigating the Justice System: a Guide for People with Disabilities."


