






























WELCOME MOYA!






Family Law at the Library Pilot Project



- "Opening the Dialogue" (May 2013) was the first time the world of law had brought together legal professionals and SRLs to discuss the state of the Canadian justice system
- 5 years later, NSRLP is hosting "Continuing the Dialogue"

Conflict Coaching for SRLs



- Fall 2017, Windsor Law first offered the first for-credit SRL Conflict Coaching class in a North American law school
- Instructor is Georgette Makhoul
- Pairs Windsor Law students with SRLs
- Class includes examination of the reasons for the rise in SRLs and implications for the practice of law; understanding the scope and limitations of a "legal coaching" model; common challenges faced by SRLs.


